EXHIBITOR CONTRACT

Tuesday, September 25th, 2018

Treetops Resort – Gaylord, MI

I hereby contract with the Michigan Water Environment Association (MWEA) to participate in the **Northern Michigan Operators Seminar** to be held on **Tuesday, September 25th, 2018** at the Treetops Resort, in Gaylord, MI. I agree to pay the exhibit fee of **\$245.00** and I agree to all of the terms of the Liability and Responsibility Clause, as stipulated. The fee paid includes the seminar and lunch for one person. **Additional representatives must pay an additional fee of \$30.00 each.**

In signing the Exhibit Contract, the exhibitor agrees to assume the entire responsibility and liability for losses, damages and claims arising out of injury or damage to exhibitor's displays, equipment and other property brought upon the premises of the designated Facility, and shall indemnify and hold harmless the MWEA and the designated Facility and the agents, servants and employees of each Facility for any and all such losses, damages and claims.

The exhibitor also agrees that the MWEA and the Facility will not be responsible for any injury, loss or damage that may occur to the exhibitor, the exhibitor's employees or property or to any other person prior, during or subsequent to the period covered by the Exhibit Contract provided said injury, loss or damage is not caused by the willful negligence or wrongful act of an employee of the Facility and agrees to expressly release the MWEA and the Facility against any and all claims for such injury, loss or damage.

It is mutually agreed that it is the duty and responsibility of each exhibitor to install their exhibit before the opening of the exhibit and to dismantle it immediately after the close of the exhibit. All exhibits can be set up starting at 7:00 a.m. on Tuesday, September 25th, 2018. Exhibit booths include: (1) 8' covered table, (2) chairs, and 110-volt electrical service (upon request). Vendors will also be given an opportunity to speak during the scheduled vendor update, as well as several opportunities throughout the program to meet and talk with attendees. Note: Please contact MWEA in advance if you have large equipment or oversized displays.

This contract allows ONE seminar registration (including lunch). Additional representatives will be charged **\$30.00** each.
